- 2. Signing the appropriate Agreement with the vendor
- 3. Completion of Test Procedure as per Annexure 4
- 4. Ensuring all the security measures as issued by BSNL,DOT and LEAs
- Ensuring the Port binding of corresponding customer ports & conducting MONTHLY AUDITs on services
- 6. Ensuring proper utilization of ports
- 7. Commissioning of OLTs
- 8. Intimating the commissioning date of OLTs to respective NOC
